

### **Summary of the decision**

We have decided to grant the permit for the operator, subject to the conditions in the permit.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environment protection is provided.

When referred to in an environmental permit, these rules will allow the operator to operate a Household, Commercial and Industrial Waste Transfer Station with waste treatment at a specified location, provided that the permitted activities are not carried out within 500 metres of a European Site<sup>1</sup>, Ramsar site or a Site of Special Scientific Interest (SSSI). Furthermore, specified waste cannot be treated outside a building within a specified Air Quality Management Area (AQMA)<sup>2</sup>. Permitted wastes are limited to non-hazardous wastes and do not include hazardous wastes such as asbestos. The total quantity of waste that can be accepted at a site under these rules must be less than 75,000 tonnes a year. With the exception of specified waste, all bulking, transfer or treatment of nonhazardous waste must be carried out inside a building. Wastes can be bulked up for disposal or recovery elsewhere and can also be treated by sorting, separation, screening, baling, shredding, crushing and compaction. These rules will not permit the burning of any wastes, either in the open, inside buildings or in any form of incinerator.

These rules do not allow any point source emission into surface waters or groundwater.

## **Key Issues of the decision**

### **Environmental risk**

The environmental risk will be minimal subject to the activities being carried out in accordance with the standard rules requirements. The treatment and storage of waste will be undertaken within the confines of the building where the base is made up of re-inforced impermeable concrete. No drainage is linked to the inside of the building.

Outside the buildings, the waste reception area is covered with impermeable hardstanding.

The area environmental officer is aware of the application and the operator and does not have any objection to the granting of the permit.

### **Conservation**

There are no areas of conservation within 500m of the site.

### **Groundwater**

The site is underlain by a major aquifer. However, the impermeable hard standing will provide protection if they are adequately maintained.

### **Air quality**

The facility does not lie within an air quality management zone. There are no air quality issues.

### **Operational techniques**

The operator has confirmed that a management system is in place and the site will be operated to meet the requirements of the conditions within the standard rules permit.

### **Monitoring and compliance**

There are no monitoring requirements

### **Operator**

The site will be managed by Paul Curtis and Alex O'Gorman who are appropriately qualified to operate this facility. They hold WAMITAB CoTC Level 4.

### **The facility**

The facility is located within the Trafford Park Industrial area adjacent to the Bridgewater Canal. The waste processing operation will take place within existing building which will be reclassified.

Planning permission for the facility was granted on the 28<sup>th</sup> August 2009.

There are no commercial or confidentiality issues.

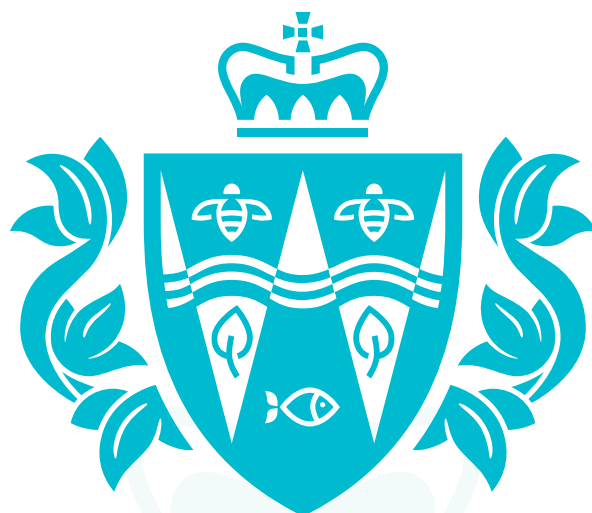
